Satellite Session on Drugs as Reinforcers, Baltimore, MD, June 3, 1978

ISGIDAR sponsored a scientific meeting as a satellite session to the 1978 annual meeting of the Committee on Problems of Drug Dependence. This year we had formal registration with a registration fee of \$5.00. Fifty-one individuals registered and paid the fee for the meeting. In addition, a number of others (members of the Committee on Problems of Drug Dependence and early arrivees to the general session) stopped in for one or more of the papers, consequently the meeting was well attended and lively. Paper presentations were given in the morning and afternoon. The program for the paper session was as follows:

Gerald A. Young, J. Edward Moreton, George, F. Steinfels and Naim Khazan, University of Maryland School of Pharmacy, Baltimore, MD. Self-administration of 1-alpha-acetylmethadol (LAAM) and its N-demethylated metabolites, Nor-LAAM and Di Nor-LAAM, in the dependent rat.

William Woolverton, J. Marshall Newbern and Robert L. Balster, Medical College of Virginia, Richmond, VA Effects of lithium on choice between food versus cocaine in rhesus monkeys.

Marc Risner, Addiction Research Center, Lexington, KY. Self-administration of drugs in the dog.

Alice M. Young, Marilyn Jensen, Laurie Rice and Travis Thompson, University of Minnesota, Minneapolis, MN. Effects of brief stimuli correlated with the availability of food on responding maintained by intravenous codeine.

Steven R. Goldberg and Roger D. Spealman, Harvard Medical School, New England Regional Primate Research Center, Southborough, Mass. Control of extended sequences of drug-seeking behavior by environmental stimuli.

Gary J. Gerber and Roy A. Wise, Concordia University, Montreal, Canada. Medial forebrain bundle lesions selectively attenuate self-administration of amphetamine, cocaine and apomorphine in rats.

Stanley R. Lorens, Loyola University Medical Center, Maywood IL. Are there positively reinforcing effects of drugs with abuse potential mediated by the opiate receptor?

Roy C. Pickens and Phillip M. Catchings, University of Minnesota Medical School, Minneapolis, MN. Metabolic factors in human drug self-administration.

Marilyn E. Carrol, Richard A. Meisch and Charles France, University of Minnesota Medical School, Minneapolis, MN. Effects of food deprivation on etonitazine consumption in rats.
